### Do You Budget For Your Equipment Costs And Replacements? Field, Office, Jobsites

Do you budget for your equipment? Maybe you don't sit down and write out a budget (although we recommend you do), but I'll bet you plan for some of these expenses:

- The truck you need to purchase (or replace), finance, maintain, along with the cost of licenses and plates
- Maybe you own your shop or office, so you budget for outdoor maintenance – mow the lawn, plow the snow, or keep under a car port, furnace replacement, roof repair
- How about scaffolding replacements or upgrades? Aging saws, trailers

You don't buy a truck and expect it to work year after year without gas, oil changes, maintenance, or tires, so you budget for the upkeep and replacement. You keep up on insurance, license plates, and other fees because you count on the equipment. It will need to be replaced after a few years, and you're not surprised when you start thinking about how many miles are on it, what it's costing to keep running, and what you might get on a trade-in.

Most businesses have these expenses built into their budgets, or at least built into their estimating process — got to have the trucks and trailers running, insured, and safe. When you put a bid together, you have your burdened cost of labor, but you also have allowances for using (or renting) equipment, including the cost of cartage to move big items, consumables such as diamond blades, gas/oil, just to name a few.

Twenty-five (25) years ago, only the field equipment and an allowance for overhead were part of the budgets, **not computers. Now they're a critical,** non-negotiable part of doing business and they need security, maintenance, updates, and replacement when the time comes. Tablets and cell phones to get on Teams calls; estimating software; accounting software to do your billing and track your job costs; email; jobsite photos; electronic certified payroll reports; field time collection.

But, I rarely see construction companies budget for their computers. Equipment ages and needs to be replaced. Just like old models of cars, there are old 'models' of Operating Systems and critical software that need to be upgraded or replaced. Newer software doesn't always run on old equipment. Switches run 24/7 and may need to replaced. Firewalls need regular maintenance and security updates, just like vehicles. Firewalls also age and need to be replaced with a new 'model' that can address new intrusion attempts. These often have new features to thwart the bad guys.

Then there are backups – I see such resistance to this. Yes, it's like an insurance policy. And like insurance on a vehicle, your home, your life, you cannot afford to risk not having it. Data is a primary driver of any construction business these days, and you have to have backups to restore in case of a disaster, yes, or just employee error that accidentally unleashes ransomware.

Plan ahead – build the cost of IT and computer replacements into your overall company budget and be realistic!

How much have you billed? What are your costs to-date? Who worked on that job? What are your receivables? How much are your payables and who do you owe? And what about that lawsuit that requires you pull a lot of history?

It's surprising how much push back, or delay we get when we point out that these critical systems need attention, replacement, or upgrades. Then when these recommendations are delayed or declined, the next call we get when things aren't working, or go down, is that we should have known this was going to happen (we did). Now our client has to come up with some serious cash to get stable again, not to mention the unexpected work interruption. This is what we do, this is what we know—computers! You count on our computer expertise, and we ask that you let us help you with your computer needs, replacements, upgrades, and planning.

Plan ahead – build the cost of IT and computer/software replacements into your overall budget and be realistic. You need computers to run a construction company these days. 

## American Payroll Association Breach

The American Payroll Association just notified its members that it has suffered a breach. Threat actors installed skimming malware on both the log in web page of the APA website and the checkout section of the association's online store by exploiting a vulnerability in the APA's content management system. It was discovered around July 13, but before it could be removed unauthorized individuals gained access to information including first and last names, email address, job title/role, primary job function, company structure, gender; date of birth, address (either business or personal), including country,

### Changing Your Password In The Hosted Environment

Our password policy has been published and shared with all our clients, and we continue to share it. We recommend that our clients enforce a minimum of 8 characters with a combination of upper and lower case letters, at least one number, and at least one special character (\*, +, !, @, #, etc.).

If you're in our hosted environment and access the hosted server through a Remote Desktop Connection (RDC, sometimes called RDP) icon, you still need to change your password every 90 days or so. Ctl-Alt-Delete only works on your local machine, not in the private cloud. So how do you change the password?

To keep you informed and safe, every Monday morning we send a short technology email tip. We highlight a new threat or scam we've seen; an upcoming expiration of a service or product you use; tips on hardware and software specific to running your company; and much more!

If you're not receiving our updates, be sure to whitelist 'Infusionmail.com' which is the platform we use to safely send email to you. If you need any help, call the office and ask for Beth or a Tech and we'll give you a hand!

Using the Summary Feature in S100C

Many of us use general ledger subaccounts to track a second layer of detail under an account. On the Trial Balance and Financial reports, the single account displays, but you can also print additional detail by subaccount. Some favorite uses include multiple Vehicle Loans; Employee Loan amounts; interest expenses by bank or lender; professional services. In each of these, an additional layer of detail is important, but when presenting to a bank or board, or to maintain privacy, one number is presented.

If you run Departmental Income Statements, some of these accounts may already be broken out by the departments, so you can't add subaccounts. Or, you may have multiple equipment lenders and don't want their names on the financials, but need the named accounts to make the loan payments. So how can you present a combined total on a Financial Statement?

So glad you asked - in the 1-7 screen, there is a field called Summary. Let's take the example of having multiple loans. You can create a new account called Equipment Loans. Then in each of the actual named loan accounts, enter the 'umbrella' account number in the Summary field. In a Trial Balance, each account will present (the new Equipment Loans account is zero). In a Financial presentation (2-8 screen), these will summarize up to the new Equipment Loan account for one grand total. – CMW

#### IL Certified Payroll Change

Beginning in September 2020, the state of IL is requiring all Certified Payroll reports to be electronically filed.
