If we wrote original music to provide the background, recorded it, and gave them the rights to sell the cassettes at their events, would that cover the fee for the two of us to attend together? The answer was yes!

The Realmusic Label – The first

recording was a solo flute with background environmental sounds of a summer storm we recorded in Geneva, IL. It was entitled *Forest Song*. Our friend Carlyn Lloyd played the flute part that Larry had written and did an amazing job of capturing the mood. Our friend Bobby Thomas overdubbed the environmental recording and it was just magic to hear it all come together. We created the cassette label and insert with artwork and font selections, along with our new company logo; we were in business!

In the coming years we recorded *Mountain Soliloquy* for brass instruments with sounds recorded in the Appalachian Mountains, then *Embrace the Wind*, which featured clarinets with classical guitar and the sounds recorded on a sloop on Lake Michigan. The field recordings were handled by our friend Vern Williams from Janesville, WI.

What does all of this have to do with computers? While we were growing our distribution of these audio cassettes, and eventually the sampler CD, computers were just heating up in the construction industry. Larry's dad was a Mason contractor and very active in his associations. Some of the larger Masons in the Chicago area were beginning to use computers to print AP checks and help with Payroll. They knew that the computers could help them turn around bid alternates faster and more accurately. They also knew they would need help with the computers and wanted someone they could trust. Larry had worked for his dad over the years and Larry knew many of these men. When they found out about Larry's computer background, we started getting calls to come over and help. With the money from the computers, we could continue to build the music business while Larry finished school and his internship.

Right Time, Right Place - With our construction background, growing knowledge of computers, and our small business experience, requests for com-

puter assistance grew pretty fast. All support was onsite at that time. We helped set up the networks, the printing, backups, and helped the users with their computers. We attended many of the Mason Contractor Association events, meeting many Masons from all over the US.

This grew into educational training sessions to use the computers. Since Larry's dad was an Engineer by training, his methodical process of estimating along with his math skills were a perfect match for the programming languages. We actually wrote an estimating program, Benchmark Estimating, and had a good following. We held trainings at the various industry events, including classes on Estimating best practices.

During that same time, one of our Mason friends was interested in Master Builder for accounting and project management. Looking at the software, we decided to attend the training in California. There's an entire backstory to this event-turns out a nerve in Larry's arm was dying and the pain was out of control. Check out our website to see the interview and hear the story. In the end, we did the first Windows upgrade and Larry's programming background

made all the difference. We moved into Sylvan Learning Centers and Pre-GED software for PC's and Apples, and lots of custom reports for Master Builder.

#### Principles by Ray Dalio

The book is broken into three sections, almost three different books: Where I'm Coming From; Life Principles; Work Principles; Conclusion. The opening is about Ray Dalio and how he found his career passion, his journey to find and lead a team, and ultimately the growth of Bridgewater Associates.

The primary focus is Mr. Dalio's 'idea meritocracy' concept in which he works through defining what that means personally and in his business, and the principles he has developed over the years to live-out this concept. As the com-

#### Sonicwall Firewalls—Critical Updates, All Devices

You may have already seen our update on this. Sonicwall has security firmware updates across its product lines, including all TZ and NSA units, two of the most popular products used by us and our clients.

Is there a problem? No, nothing 'dire.' Sonicwall is one of many IT vendors who is taking the security risk seriously and continuing to lock down their devices. Firewalls are the first line of defense for your network or home office; these are critical for the safety and security of your data.

We have a list of all Sonicwall units across our clients. We'll schedule these updates with you since there will be a short work interruption. We'll log into the firewall, install the firmware update, then it will require a reboot of the unit, which is when the interruption will happen, so that's why we want to do some planning with you. The whole process will be an hour or less.

#### Anti-Spam—Moving to M365

Many of you have just moved, or are in the process of moving to Microsoft 365 for email. From a day-to-day perspective, not much has changed; you launch Outlook and work through your email. You already have email on your phone, too. If you've used Outlook Web Access (OWA) in the past, then you'll just log into Office.com to get email from the internet; easy.

What has changed is your anti-spam. Within the last two years, Microsoft's anti--spam offering has matured and is ready for prime-time. We moved to it last year, ending our AppRiver service. I have to say I'm really glad to have made this change since I don't have to log into a separate portal to review email caught by the spam filters, and I don't have to request that someone flag something as 'never' or 'always' block. But, I'll also admit it's a transition.

With M365, I can right-click on any email address and choose 'Junk' to either flag something as 'Always Block' or 'Never Block' (and there are a few other choices, too). I can also click on my Junk folder and view all the email that has come in that might be junk. We have a rule that automatically removes these after 60 days so my Junk folder doesn't get too out of hand. If anything in that Junk folder is legit, I just right-click and make the change.

Lastly, anti-spam actually has a 'learning' component. As you work with the incoming email, it begins to 'learn' what you do and don't want to let through. During this process, we ask that you remain calm and be patient. In no time at all this will get better, and in the meantime, you have more control and one less portal to visit. This is a 'win' for each of our clients, too. If you have questions or need some help, give us a call. - CMW

## Shiny New Gadget Of The Month:



### Camera Snorkel Mask

Who's ready for an underwater adventure?

The camera snorkel mask captures photos and video so you can share your underwater explorations. The camera is built into the dive mask and is meant to accompany you on diving/snorkeling trips up to 130 feet deep.

While you provide the manpower to propel yourself for your dive/ snorkel, four (4) AAA batteries run your camera snorkel mask. It uses color-coded LED lights so **you know if you're taking photos** or video as you explore the underwater domain. Be sure to get some footage of Aquaman or SpongeBob if you see them!

Note that the camera snorkel mask does *not* come with internal **memory, so you'll need to insert a** micro SD/SDHC card to save all your recordings (and prove you saw what you say you did). It records about 2 hours of video or about 2,800 images through a 135 degree lens. You can buy extra GBs to record more – you'll get an extra 700 images or 30 minutes more video per 1GB of memory.

Sage 100 Contractor – Version 23 It's been a couple of years since S100C version 22 was released back in 2019. There have been minor updates, but nothing major – until now. On July 29<sup>th</sup>, Sage expects to release version 23. We don't have the release notes yet with the feature updates, but we have info about some very important structural changes.

S100C has API's that allow third party

programs to pull data from and/or write data to specific tables in Sage 100 Contractor. Some example companies with integrated products include Trivantis, Sage Paperless, Sage Service/ Field Operations (SSO/SFO), ProCore, DASH, FieldFlo, and others. Most of the **Syscon integrations do not use the API's** since we use the actual tables wherever possible for a full integration, so our FIT System is not impacted by this release.

The Sage API's will now require .NET 4.8 to be installed on the server to run these third-party programs. What does that mean to you? If you use any integrated programs with Sage 100 Contractor, then you need to contact those vendors about an upgrade BEFORE you move to version 23. As of this writing, SSO/SFO from IFScore has already announced that they have an **upgrade available. You'll want to** coordinate the third-party upgrades as **part of the S100C upgrade so you don't** experience any work flow disruptions. If **your vendor doesn't have a new release**

-Bret Carpenella, Finance Manager, MBA Building Group available, then you'll have to wait to install the Sage upgrade.

Also, in January 2022, the Microsoft 2012 server Operating System (OS) will be end-of-life. They'll still have support and security updates, but no new features will be available as Microsoft begins the cycle to discontinue this operating system. Hard to believe but it's been 10 years since this OS came out. Sage 100 Contractor has been compatible with Server 2016 R2, then more recently with Server 2019.

**'If your vendor doesn't** have a new release **available, then you'll** have to wait to install the **Sage upgrade.'** 

With all this in mind, if you're running Server 2012 R2, and any version of .NET less than 4.8, this is a good time to consider upgrading your server to Server 2019 and the latest stable .NET release. If you're in our hosting environment, the timing couldn't be better! All of our hosted clients will be moving to Azure this year, which will include the latest Server OS and the latest .NET release.

In preparation for all of these changes, reach out to any third-party vendors who have integrations with your S100C software and ask them about their plans to provide an upgrade that accommodates the .NET 4.8 release. **We're pretty sure that Sage will follow** previous protocol and only release the 2022 Federal and State tax table updates for this latest version 23 release. That means you have about 4 or 5 months to get things in order and make the changes.

Most of us don't like change, but there are some 'aligning of the planets' here that are really a great opportunity –

upgrade your third-party software, upgrade your server Operating System, upgrade your .NET software (on the server), and if you're in our hosting environment, move to our Azure hosting. You'll be all set to have a fantastic 2022! - *CMW* 

Tracking COVID Sick Pay–Our California clients are now mandated to track earned and used COVID sick pay.

Sage is suggesting you use the Custom Fields in the Employee screen to track the remaining hours and add those new **fields to your check stub.** This isn't our favorite option since it requires manually updating each employee every time they use any COVID sick leave.

We recommend using a formula on your check stub that will calculate the remaining COVID sick leave available based on the hours used with your COVID Absence Codes. No manual updates required!

Federal 941 Taxes – Tracking Many years ago, we had separate General Ledger numbers for Federal withholding, FICA, and Medicare. Now that our calcs take care of the limits, and these are all reported as a 941 payment, we typically have one General Ledger number. Cut the checks, post the payroll, determine the Federal 941 payment amount, and confirm with the liability account; pay, post, and confirm.

One of the most common cleanup items we find is multiple GL's with odd balances and no clear way to tie out. We recommend you consolidate the calcs to one GL and track from there. - *CMW*

# What is Advanced Threat Protection?

Advanced Threat Protection (ATP) is a cloud-based email filtering service that helps protect your organization against unknown malware and viruses.

Microsoft's **Defender for Office 365** includes ATP to protect organizations throughout the lifecycle of an attack. This level of security is part of the M365 Premium or M/O365 E3 or higher license series.

Microsoft's ATP also includes a Safe Links feature, a Safe Documents feature, and a Safe Attachments feature for added protection from possible cyber security threats.

Safe Links scans inbound URL links (websites) sent by other users. This is in addition to anti -spam and anti-malware protection. When a dangerous URL is identified, Microsoft has a pop-up window that warns that the link leads to a malicious website. There is an option to go back to the message or continue anyway, but proceed with caution!

Safe Documents scans documents and opens files up in a protected view. A user can't open the document until the scan is complete, ensuring that the file is safe.

Safe Attachments scans email attachments before they reach an inbox.

Please note that these Microsoft security features must be configured and users will need training. These are available at the higher license levels.




